Bring Your Own Device (BYOD) and Internet Acceptable Use Agreement

I understand that:

- The only purpose for school computers and other I.T. resources is to support teaching and learning;
- The school will do its best to keep me (the student) safe while using global information systems;
- I know that I am not permitted to access material through the Internet that is offensive, dangerous, inappropriate or illegal, and that I am forbidden to pass on such material by copying, storing or printing it;
- If I use e-mail at school, I am not permitted to send any messages that are offensive, dangerous, inappropriate or illegal;
- Some device information may be held by the Meraki Systems Manager and the School, and may be audited if necessary;
- My device will have virus protection to keep my device and the school system safe;
- I may use the Internet or e-mail at school only if there is a teacher supervising me;
- My assigned school e-mail address is the property of Drury School. This means that staff may access this at any time for auditing purposes.
- The school may use unnamed examples of my school work and images of me taking part in school activities for educational purposes on the Drury School website, blogs or other publicly available media;
- I will not allow other students to use my personally owned mobile device (laptop, iPad, iPod etc.);
- I will not use other students personally owned devices;
- Drury School is not liable for any breakage, damage, loss, or configuration of my mobile device;
- The school can ask for specific apps/software to be downloaded on personal devices, which will need to be downloaded before connecting to the school wireless system;
- It is expected that mobile devices are charged before coming to school. Only in special circumstances may it be charged in class, and this is at the discretion of the teacher;
- There will be consequences for any breach of the above, which may result in being banned from bringing to school a personally owned mobile device.

I understand how important it is to:

1. *Take care of Information Technology resources*

- Be careful with all equipment;
- Use only school software on school I.T. tools;
- Use only apps approved by the school on my mobile device while at school.

2. *Be considerate of other users*

- Share available school owned equipment;
- Take care not to scan or display graphics, record or play sounds or type messages that could cause offence to others;
- Remove immediately from the screen any material that would not be allowed at school that I accidentally come across, and I will inform the teacher straight away.

3. Be responsible for privacy and security

- I will not give anyone on the Internet information about myself or anyone else – this includes addresses, phone numbers, or photographs;
- I will inform the teacher if I come across a virus, security problem, or anything that might be considered inappropriate or offensive.
